

Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting Release of Liability, Waiver of Legal Rights and Assumption of Risk for Kite Force Academy LLC

In consideration for the renting, purchasing or leasing of Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting from **Kite Force Academy LLC** and/or the utilizing of the facilities, ground school, instruction, premises, and equipment of **Kite Force Academy LLC** in engaging in the sport of Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, and Powerkiting, ground instruction, flight instruction and related activities, (hereinafter collectively "Kitesurfing", "Kiteboarding", "Snowkiting", "Landboarding", "Landkiting", "Windsurfing", or "Powerkiting"). I hereby understand and agree to this Release of Liability, Waiver of Legal Rights and Assumption of Risk and to the terms hereof as follows:

1. I acknowledge that Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting is an action sport and recreational activity involving travel in three dimensions and such activity is subject to mishap and even injury to participants. I understand I may suffer a broken limb, paralysis or fatal injury while participating in the sport of Kitesurfing, Kiteboarding, Windsurfing, Snowkiting, Powerkiting, Landkiting or Landboarding. I further acknowledge that there are no warranties applicable to the purchase, rental or lease of Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting equipment by me and that all warranties whether expressed or implied are excluded. THERE IS NO WARRANTY OF MERCHANTABILITY OR THAT THE SAID KITESURFING, KITEBOARDING, SNOWKITING, LANDBOARDING, WINDSURFING, LANDKITING AND POWERKITING EQUIPMENT IS FIT FOR ANY PURPOSE, and that I am accepting the said Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting equipment as is and I hereby acknowledge that I will personally examine the said equipment prior to my using of the same (Initial here _____).
3. I hereby RELEASE AND DISCHARGE KITE FORCE ACADEMY LLC, the State of _____, the town (or city) of _____, and their officer, directors, elected officials, agents, employees, instructors, pilots and owners of equipment and the land used for Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting activities (hereinafter collectively referred to as "Released Parties"), from any and all liability, claims, demands or causes of action that I may hereafter have for injuries / damages arising out of my participation in Kitesurfing, Kiteboarding, Windsurfing, Snowkiting, Landboarding activities, including, but not limited to, losses CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES (Initial here _____).
4. I understand and acknowledge that Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting activities have inherent dangers that no amount of care, caution, instruction or expertise can eliminate and I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY SUSTAINED WHILE PARTICIPATING IN KITESURFING, KITEBOARDING, SNOWKITING, LANDBOARDING, WINDSURFING, LANDKITING AND POWERKITING ACTIVITIES WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASE PARTIES (Initial here _____).
5. I further agree that I WILL NOT SUE OR MAKE A CLAIM against the Released Parties for damages or other losses sustained as a result of my participation in Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting activities (Initial here _____).
6. I also agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims, judgments, and costs, including attorneys' fees, incurred in connection with any action brought as a result of my participation in Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting activities. (Initial here _____).
7. I will take full responsibility for, and hold harmless Released Parties for any injury that I may suffer or inflict upon others or their property as a result of my engaging in Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting activities (Initial here _____).
8. I agree that I will operate the said Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting equipment in a reasonable and safe manner so as not to endanger the lives of persons or property of any individual (Initial here _____).
9. I have read and understood the above and acknowledge that the same constitutes a release of liability and a waiver of my legal rights and also acknowledgement of the assumption of liability by me of all risks arising out of my engaging in Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting activities (Initial here _____).
10. I further represent that this Release of Liability, Waiver of Legal Rights and Assumption of Risk shall continue in full force and effect for so long as I engage in Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting activities which are in any way connected to or with the Released Parties (Initial here _____).
11. I further represent that I am at least 18 years of age, or that as the parent or (adult) legal guardian, I waive and release any and all legal rights that may accrue to me, to my minor child or to the minor child for whom I am (adult) legal guardian, as the result of any injury that my minor child, the minor child for whom I am (adult) legal guardian or I may suffer while engaging in Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting activities (Initial here _____).
12. I hereby expressly recognize that this Release of Liability, Waiver of Legal Rights and Assumption of Risks is a contract pursuant to which I have released any and all claims against the Released Parties resulting from participation in Kitesurfing, Kiteboarding, Snowkiting, Landboarding, Windsurfing, Landkiting and Powerkiting activities including any claims by the negligence of the Released Parties by any of the undersigned (Initial here _____).

**DECLARATION OF FITNESS FOR KITEBOARDING, KITESURFING, LANDKITING, LANDBOARDING,

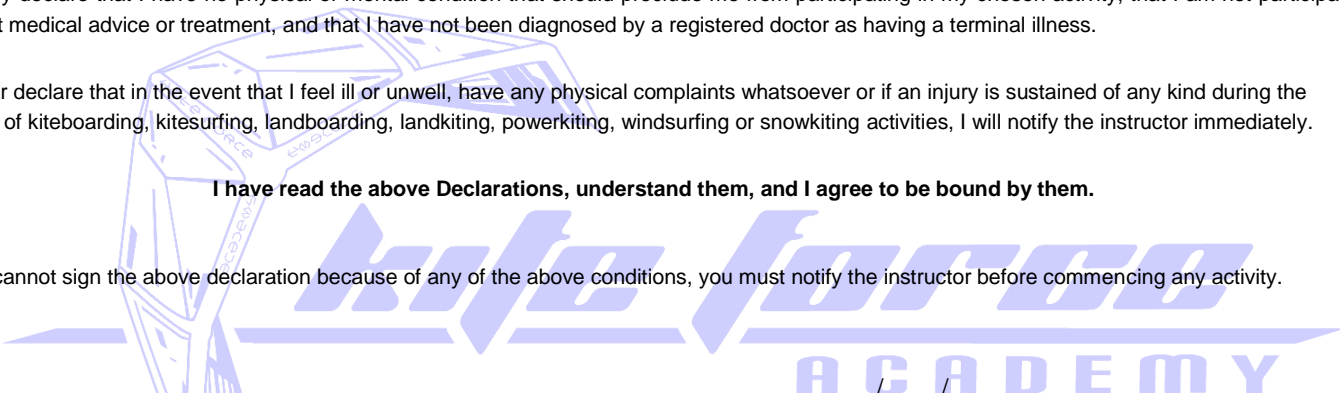
